Property Manager's Corner

Dear Residents,

Per your lease, the term "guest" means a person on the premises with the consent of a household member.

Not to assign the lease or to sublease the premises.

Not to provide accommodations for boarders, lodgers, or others not listed on the lease as household members, except as provided in paragraph (D) of this Section, and not allow any person not on the lease to use a housing authority address as his/her mailing address without the written permission of management.

To use the premises solely as a private dwelling for the Resident and the Resident's household members identified in the lease, and not to use or permit its use for any other purpose except as provided for in Section V. (B) of this lease.

That guests may visit with the consent of a household member. The Resident agrees that no member of the Resident household authorized to reside in the unit shall have a guest for more than 14 days within a calendar year without the prior written consent of the EPHA.
