ATTENTION RESIDENTS- FEBRUARY RENT


- Rent is due on the 1st of each month. The last day to pay rent is **February 12th, 2024,** at 5:30 pm.

Household Changes

Please remember to report any household changes in writing within 10 days of the change. This refers to the birth or adoption of a child, marriage, divorce, or income increases or decreases.

Smoke-Free Policy

All East Point Housing Authority's properties are Smoke-Free Properties. All residents were notified of this policy reminder in December. There is no smoking in the apartments, this includes common areas. Three violations will be considered a repeat violation of the terms of the lease and will be cause for eviction. Smoking not only affects your household, but it also affects your neighbors. If you would like to quit smoking and would like information, please contact our office.

For help quitting smoking, contact the Georgia Tobacco Quit Line at 1-877-270-STOP (7867). This is a FREE service, available 24/7, that provides one-on-one personal counseling via telephone, text, and web-based options to help anyone over 13 quit smoking and vaping. While supplies last, Georgia Tobacco Quit Line is offering certain nicotine replacement therapies free of charge for individuals who enroll.
